## The Bavarian State Parliament's Committees



Many citizens associate the term “Bavarian State Parliament“ with the image of a plenary session in a plenary chamber. However, the standing committees that are appointed for the duration of the electoral term are just as important to the parliamentary work. Each of the currently 14 standing committees is responsible for one area of politics that its members specialise in. They advise on bills and motions and submit recommendations for a resolution. As a result, the committees prepare the content for the plenary session's meetings and decisions.

The committees can request the presence of any member of the state government at their meetings. State government members and their officers have access to committee meetings and must be heard at any time. The committees also deal with petitions and complaints from citizens and take a final vote on these.

All of the Bavarian State Parliament's parliamentary groups are represented on the committees, which have 14, 18 or 21 members depending on their field. At the same time, the political majorities on the committee must correspond to those in the Bavarian State Parliament's plenary. The committee chairmanships are also distributed across the parliamentary groups based on relative strength. The parliamentary groups then decide internally which member of Parliament they delegate to a committee and who should take over the chairmanship or vice chairmanship, as necessary. The committees generally hold public meetings.

## The Committee on Public Service Affairs

### Duties

The Committee on Public Service Affairs is one of fourteen permanent committees of the Bavarian State Parliament. 14 members of Parliament in total belong to the committee: six CSU members, three members from FREIE WÄHLER (FW), two members each from AfD and ALLIANCE 90/ THE GREENS (GRU), one SPD member.

The committee has existed in its current form since the start of the first electoral term in 1946 and is unique in Germany. In no other federal state do public service civil servants and employees have a parliamentary body that is exclusively responsible for their interests.

The committee deals with issues relating to civil service and collective bargaining law, salary and pension matters as well as the regulations of personnel representation law.

In addition, its responsibility includes issues related to disability and equality if public service personnel is specifically affected. The committee also leads on all matters that are related to training junior employees for public services and the continuous training of employees.

The committee's discussions on draft legislation and motions focus, among other things, on working conditions and prospects for employees, further improving the work-life balance, modern forms of work and recruiting and securing skilled labour for the public sector. By dealing with petitions and complaints from public service employees, the committee also deals with specific concerns of employees from all areas of the civil service on an ongoing basis. Their concerns often relate to employment and transfer requests, promotion opportunities as well as benefits and pensions.

The committee also receives status reports from the State Government in order to actively accompany human resources measures and change processes in the administration. The committee also makes fact-finding visits to various administrative and judicial authorities in order to obtain a comprehensive picture of the employment situation in public services.

### Meetings

The meetings always take place on Tuesdays during sitting weeks. They are convened and chaired by the chairman. Besides the committee members and head of the committee office, state government representatives responsible for the specific agenda items also attend.

With important political issues, responsible members of the government are also present. The Bavarian State Parliament's shorthand writers' service documents the meetings.
