1985: Abitur [A-Level equivalent] at Kronberg-Gymnasium secondary school in Aschaffenburg, followed by basic military service in Kassel and Wolfhagen; 1986: Law degree at Julius-Maximilians-Universität Würzburg, also studied history and philosophy, scholarship from the Konrad-Adenauer-Stiftung foundation; 1992: First state examination in law in Würzburg; from April 1992: Legal intern in Aschaffenburg, Würzburg and Frankfurt; 1995: Second state examination in law; from February 1995: Research assistant, later lecturer and assistant professor at the Chair of International Law, Political Science and Bavarian and German Law at Julius-Maximilians-Universität Würzburg; 1997: Doctorate at Julius-Maximilians-Universität Würzburg, Bayerischer Habilitationsförderpreis award for habilitation projects; 1998-1999: Research trips to the USA; 2002: Habilitation at Julius-Maximilians-Universität Würzburg, qualification to teach public law, European law and international law, and subsequently chairs as acting professor at FAU Erlangen/Nuremberg and the University of Bayreuth as well as teaching assignments at the Catholic University of Eichstätt-Ingolstadt; since April 2007: University of Wuppertal (BUW), Chair of Public Law, specialising in European and international business law (not active since start of State Parliament mandate);
